Historic Elmira, Inc. will present the twelfth annual awards for sensitive restoration and preservation projects within the Elmira area. The awards program features two categories – Advocate or Project.

Historic Elmira, Inc. is a 501(c)(3) non-profit organization, founded in 2007, with a mission to champion historic preservation in the Elmira region by providing education, advocacy, collaboration, and facilitation in activities supporting the preservation and enhancement of buildings and sites that are of historic significance.

**Award Categories:**

- A. Advocate.** The Advocate Award will recognize creative, inspirational leaders, groups or organizations, who, either in the public eye or from behind the scenes, have been stewards of historic preservation, have encouraged the protection of historic resources, and continued to strengthen and broaden the historic preservation movement in the Elmira area. The Advocate Award celebrates government officials, community leaders, local business owners, journalists, and other dedicated preservationists whose advocacy contributed to the protection of the Elmira area's architectural heritage.
  
- B. Project.** The Project Award will recognize any historic preservation, restoration, rehabilitation, or adaptive reuse project. Those nominating a project for award may select the category they feel best reflects their project. Landmark status is not required for consideration of an award.

Project nominations will be reviewed based on such considerations as the importance of the effort or project to the long-term preservation of the building or site, guided by basic preservation principles as outlined in the Secretary of the Interior's Standards for Rehabilitation which can be found at the National Park Service website <https://www.nps.gov/tps/standards/rehabilitation.htm> the impact or potential impact of the project on the neighborhood; the project's economic impact on the community; and the significance of influence on historic preservation within the Elmira area.

*Incomplete nominations will not be considered.*
